

SAMPLE BALLOTS

Approximately three weeks prior to each election sample ballots will be mailed to all registered voters who have not requested a vote-by-mail ballot or requested to receive their sample ballots by email. To request that your sample ballot be emailed visit our website.

VOTING SYSTEM

The Elections System & Software DS200s digital scan tabulators are used to count ballots at each precinct and early voting location.

Voters receive a paper ballot, mark their ballot by completing an oval to the left of each of their choices, and place it into the DS200 for immediate tabulation. Voters are notified of improperly marked ballots and given an opportunity to review their ballot and obtain a replacement when necessary.

The Elections Office also provides a ballot marking device with an audio ballot feature for persons with disabilities at each of our voting locations.

Vote-by-mail ballots are counted on a high speed tabulator at the Elections Office. Results from early voting, precincts, and vote-by-mail ballots are combined at the Elections Office. After the polls close, the election results are released to the public and posted on our website.

HOW TO MARK A BALLOT

Using a black pen, voters fill in the oval on their paper ballot, to the left of their choices.



After marking the ballot, the voter inserts their paper ballot into the DS200 where it is tabulated immediately.

CHECK YOUR VOTER INFORMATION

Visit votesjc.com, then choose the link shown above on our website to check your voter information, including your party affiliation, polling place, and vote-by-mail ballot status.

Voter registration deadline is 29 days prior to an election.

You must be registered to vote by the deadline to be eligible to vote. If you have a Florida Driver License or Florida ID card you may register and submit your registration online.

YOUR VOTER INFORMATION CARD



Once registered, a Voter Information Card is mailed to you.

This is not a form of identification for voting.

Your Voter Information Card shows the districts you are eligible to vote in, your registered party affiliation, and where you vote on Election Day. If your polling places changes, you will be mailed a new card with updated information on where to cast your ballot on Election Day.

FLORIDA IS A CLOSED PRIMARY STATE

Florida is a closed primary state. You may only vote for candidates of the party in which you are registered in a primary election. This includes the presidential preference primary election held every four years. Some races are nonpartisan and appear on all primary ballots. Voters registered with no party affiliation or a minor party receive a Nonpartisan ballot and cannot vote for party candidates.

Deadline to change party affiliation is 29 days before a primary election.

VOTE YOUR WAY: Vote-By-Mail, Early, or Election Day

VOTE-BY-MAIL

Any registered voter may request a vote-by-mail ballot by calling the Elections Office at (904) 823-2238 or by visiting our website. Vote-by-mail ballots must be in the Supervisor of Elections office by 7 PM on Election Day. Voted vote-by-mail ballots cannot be dropped off at the polls on Election Day.

UPDATE YOUR SIGNATURE

In order for a vote-by-mail ballot to count, the Supervisor must compare the signature on a voter's record with the signature on the vote-by-mail ballot affidavit and the two must match, according to section 101.68, F.S.

To update your signature, provide the Supervisor of Elections Office with a Florida Voter Registration Application indicating a signature update.

EARLY VOTE

Regardless of your assigned precinct, all St. Johns County voters may cast their ballot at **ANY** Early Voting Site.

ELECTION DAY

Polls are open from 7 AM - 7 PM.

On Election Day, you must vote in the precinct of your legal residence. Polling locations are listed on your Voter Information Card, or check the precinct locator on our website.

PHOTO AND SIGNATURE ID REQUIREMENT



If you choose to vote in person, whether by early voting or at your precinct on Election Day, you must present photo and signature identification.

Acceptable forms of photo ID are:

Take current, valid photo and signature ID with you when you vote. If you do not have proper ID, you must vote a provisional ballot. (F.S.101.043)
